# Helping a telecom provider investigate and safeguard confidential data

#### **Customer Story**

Following the rollout of Slack, a major telecommunications company turned to Mimecast Governance & Compliance Suite to help them understand the risks that resided within employee messages. Their primary concerns included preventing data loss and enabling eDiscovery within the tool.

Mimecast Governance & Compliance Suite's applications uncovered that call center employees used Slack messages to store large volumes of personal identifiable information (PII) and payment card industry (PCI) data.

### Protecting collaboration data from leaks

#### **Customer Story**

A large technology service company employs numerous consultants who work on highly sensitive projects for external clients. Typically, these consultants utilize separate communication devices—one for internal projects and another for client interactions.

This company was concerned about the risk of consultants inadvertently sharing client intellectual property through internal collaboration platforms on their separate devices. Such actions could jeopardize their reputation. They needed a system capable of detecting and reporting instances where confidential data was shared.

A large utility company has recently acquired new organizations that use their collaboration platforms for internal communication. Their Information Security team expressed concern about these acquisitions sharing sensitive trademark data.
